

FLEXIBILITY TO MATCH YOUR LEARNING STYLE

Along with the required subjects, seminar courses and electives required for their chosen specialization, students have the chance to fill out the remainder of their credits from among Japanese language and IT classes as well as those from the Graduate School of Asia Pacific Studies as part of the Core Related Courses requirement, giving them the flexibility to pursue their interests. In addition, with the ability to freely distribute their course load each semester, students can concentrate on finding internships, learning Japanese, doing research, or job-hunting during semesters (typically 3rd and 4th) with lighter credit loads.
