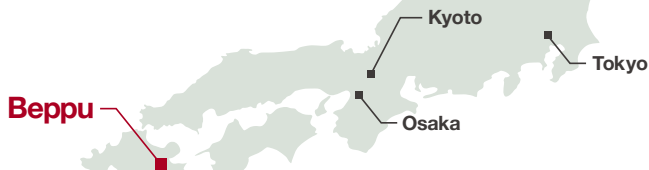
APU is located in **Beppu, Japan**, a bayside city home to 120,000 people and over 2,000 natural hot springs.

FLEXIBILITY TO MATCH YOUR LEARNING STYLE

Beyond the required subjects, seminar courses, and electives required for their chosen specialization, students have the chance to fulfill the remainder of their credits with Japanese language classes. They may also take courses from the Graduate School of Asia Pacific Studies as part of the Core Related Courses Requirement. This flexibility allows students to pursue a broad range of interests.

In addition, with the ability to freely distribute their course load each semester, students can concentrate on finding internships, learning Japanese, doing research, or job-hunting during semesters with lighter credit loads.
